NOMINATION REQUIREMENTS

Format

Please submit one (1) signed nomination form and copy of your essay question.

Please answer the following question, using specific examples that demonstrate the involvement, achievement and leadership of your nominee.

1. What achievements has your nominee made, personally and/or professionally, that are evidence of their qualifications for the 2010 Awards?

Nominations must be limited to 500 words and should be typewritten on plain paper, no letterhead. Please type the question above followed by your answer. Questions will not be included in your word count. Only nominees whose application meets the criteria requirements will be accepted.

Criteria

Business of the Year (Micro, Small, Midsize, Large, New) - The business should be recognized for outstanding products, business practices, and/or services. Involvement in the community by way of contributions to local programs, events, or community organizations beyond business practices will be considered a plus.

Legacy Award (need not be awarded every year) - This award is to recognize a private citizen or public servant who has served at least 25 years in the Northern Pima County area in multiple volunteer organizations and/or on community boards or committees. This person has demonstrated a long time dedication and devotion to the community.

Community Leader Award - This award seeks to recognize any person in the Northern Pima County area with at least five (5) years service who has made significant contributions to the area above and beyond the activities and responsibilities of their present job.

Nonprofit Award - A nonprofit organization that provides direct contribution to the quality of life in Northern Pima County. This award goes to the organization that involves itself in the business community and directly assists people or events through staff or volunteer time, or other direct participation.

People's Choice Award - Best Business - A business whose efforts this year deserve recognition for their contribution to the enrichment of our community. This award will be voted on by the people via the Northern Pima County Chamber of Commerce website.

Education - This award is to recognize an individual that has promoted and demonstrated life-long learning as a key to the future success of students. In addition, this person has developed and promoted strategies that actively engage students for business education outreach. He/she has built positive, trusting and respectful relationships towards the business community and its residents.

Recipients

A selection committee will review all nomination forms and select the 2010 Award recipients. Recipients will be announced at the 2010 Annual Meeting & Awards on Thursday, August 26, 2010 at the Hilton El Conquistador Golf & Tennis Resort. Recipients are not notified prior to the event, so nominators are responsible for making sure the nominee is present.
